

On November 3, 2000, following a two-day sanction hearing with 24 witnesses, Pinsof was disbarred effective December 3, 2000. Pinsof was further ordered to pay attorney's fees in the amount of \$41,737.50 and court costs in the amount of \$5,761.19. (4 day trial)

Sidelights

Since the beginning of this year, Pinsof has been practicing law in the Midland/Odessa area. Pinsof, also a psychiatrist, was practicing under a probationary license due to a previous disciplinary action taken by the Texas Medical Board.

Type of Claim

Medical Malpractice - David Archer, a 33-year-old computer programmer, underwent a laparoscopic cholecystectomy for gallbladder disease on August 13, 1998. During the surgery, Dr. McDonald transected Mr. Archer's common bile duct and attempted a primary anastomotic repair. There was also an intraoperative tear

to the hepatic duct that was repaired by suturing. Mr. Archer developed stricturing of the common bile duct that necessitated placement of transhepatic stents. The stenting resulted in the development of a pseudocyst on the pancreas that required surgical intervention.

Dr. McDonald contended this a known complication of this type of surgery. Clear Lake Surgical Associates is Dr. McDonald's clinic.

Damages David L. Archer claimed \$475,000 in medical expenses, \$250,000 in future medical, and \$22,500 in lost wages.

Mr. Archer claimed he will need a liver transplant in the future.

Christine Archer claimed loss of consortium.

Verdict The jury found Dr. McDonald negligent. Awarded:

\$1,047,500 actual damages. 10 - 2 (2 1/2 day trial)

Prejudgment interest is estimated at \$172,791.58 making the total award \$1,220,291.58.

During deliberations, the parties reached a \$900,000/\$200,000 high/low settlement agreement.
